Diversity Richmond operates Diversity Thrift, a thrift store that receives from the public donations of clothing, household items, books and furniture. These items are then prepared for sale to the public. A significant number of volunteer services are provided in the thrift shop in sorting, organizing and preparing donated items for sale. Revenues produced by Diversity Thrift are used to fund (a) the operations of Diversity Richmond, (b) the design and provision of educational, civic and cultural programming, and (c) the provision of direct cash support for agencies and groups that provide services to Lesbian, Gay, Bisexual, Transgender and Questioning (LGBTQ+) people in Central Virginia.

Diversity Richmond occupies a 47,000 square foot facility in Richmond, Virginia that provides flexible meeting and programming space for LGBTQ+ people, for the groups that provide services to them, and for people and groups in Central Virginia that support the Organization's mission.

Diversity Richmond also provides offsite support to the community through the operation of internet, social media and networking services that tie together the efforts of groups serving LGBTQ+ people. Diversity Richmond also hosts a growing schedule of programming events produced in-house, including musical performances, discussion groups and gallery shows and specific programs for older LGBTQ+ people. -continued-

Utilizing net revenues from its Diversity Thrift and Diversity Bingo operations, Diversity Richmond provided direct cash support to non-profits, agencies and groups serving LGBTQ+ people in Central Virginia. In 2016, the Foundation provided cash support totalling \$48,261 to these non-profits, agencies and groups.

In 2016 over 8,000 people attended events produced or promoted by Diversity Richmond. Specifically, the Organization provides meeting space to three (3) twelve-step recovery programs (Alcoholics Anonymous and Narcotics Anonymous) in addition to local non-profit organizations.

The Organization is active in social media predominantly utilizing FaceBook and YouTube and had 4,984 FaceBook subscribers as of July 24, 2017.

Immediately subsequent to the tragic shooting in Orlando, social media was utilized to make subscribers aware of the tragedy and to coordinate a vigil in honor of the slain and injured parties that was attended by in excess of 2,000 people. The vigil was attended by community members at large, religious leaders, political leaders, business leaders and representatives from law enforcement. The vigil was held on Tuesday, June 14, 2016 and was promoted and coordinated exclusively from volunteers.

Specific programs initiated in 2016 by Diversity Richmond are described below:

The Iridian Gallery at Diversity Richmond is one of the few art galleries in the nation solely dedicated to promoting LGBTQ+ artists. The gallery committee is comprised of local artists who hosted a number of exhibits during 2016 and have scheduled five exhibits during 2017.
